

**UGANDA PRISONS SERVICE

2. The Entity invites sealed bids from eligible bidders for the provision of

**LOT2: Transportation of Maize Grains from Ruimi to Prisons Quartermaster Stores at 7<sup>th</sup> Street Industrial Area- Kampala**
3. Bidding will be conducted in accordance with the open **domestic** bidding procedures contained in Public Procurement and Disposal of Public Assets Act 2003, and is open to all bidders from eligible source countries.

Shs 50,000/- (Uganda Shillings Fifty Thousand Only)**. The method of payment will be **by Cash payable to Diamond Trust Bank using Bank Advice Forms**
